We are a Ticket to Work Employment Network offering job placement, job coaching, and employment support services for people with SSDI or SSI.





What is the Ticket to Work Program (TTW)

Ticket to Work is a free and voluntary program that can help Social Security beneficiaries go to work, get a good job that may lead to a career, and become financially independent, all while they keep their Medicare or Medicaid. Individuals who receive Social Security benefits because of a disability and are age 18 through 64 probably already qualify for the program.

What is an Employment Network (EN)

An EN is an entity that contracts with the Social Security Administration to provide the beneficiary with job placement and job retention services.

How It Works

Your participation begins when we develop an Individualized Work Plan (IWP) with you.

Then your career planning, job search, and job placement can begin.

Once employed your work trial period begins. The trial work period allows you to test your ability to work for at least 9 months while still receiving your cash benefits. Special rules apply depending on the benefit type you receive, SSDI or SSI.

And if you cannot continue working for any reason, because of your disability, your benefits can start again without having to fill out a new application.

Work Incentives include:

- Continued Medicare or Medicaid while you work
- Extended period of eligibility to receive cash benefits

You won't undergo medical reviews while you are using the “free” ticket and making timely progress pursuing your plan for returning to work.
